ORGANIZATION APPLICATION INSTRUCTIONS

Please read completely!



What is FMCS Operation Round Up®?

FMCS Operation Round Up® is a non-profit fund, generated by and benefiting members of Freeborn-Mower Cooperative Services (FMCS). The funds are administered and distributed according to the direction of a Board of Trustees made up of FMCS members throughout our service territory.

Who is eligible to request assistance?

Individual applicants must be current FMCS members, living within FMCS' service territory.

Organizations or charities providing services that are beneficial to the public interest, within FMCS' service territory. **FMCS Operation Round Up® is prohibited from making grants for religious or political purposes. Applications from schools must be signed by the Principal of that school.**

How do I apply for assistance?

Anyone with a specific need for funds can make application to the FMCS Operation Round Up® Board of Trustees. There are two different applications - one for families or individuals, a second for organizations. For additional forms call fund coordinator, Mary J. Nelson at 507-373-6421 x3118. Application forms are also available on the FMCS website: www.fmcs.coop.

What other information should I include with my form?

Some guidelines to consider when completing the form are:

- **Include a cover letter. Use black ink, and be legible. Unreadable applications will be returned.**
- You need to write in all areas of the application, do not leave anything unanswered. If not applicable please write N/A.
- If the funds are requested to purchase a new item or for a repair, please include three bids for the item or work. We request that at least one bid be from a vendor or supplier in the FMCS service territory if at all possible.
- If you are requesting funds to pay a particular bill/s, **include copies** of all the bills for which you are requesting assistance, and/or any other correspondence regarding your account.
- Any additional information you can supply in the form of a letter is extremely helpful to the board in making decisions regarding these requests.
- Please make sure **to sign and date** the application **and write legibly in black ink.**

If any of the information required is not complete, your application will not be considered.

When is the deadline for application submission?

The FMCS Operation Round Up® Board meets in **January, April, July, and October**. Applications received **before** the first day of the month of a meeting will be considered at that month's regularly scheduled meeting. Emergency submissions will only be considered at the discretion of the board.

Is there a limit to the amount I can request?

Yes, there is a limit to the amount of money that will be awarded to any family, individual, or organization in a twelve-month period. Limits are set by the board and may change:
\$500 Annually for an Individual, Organization or Charity

If my request is considered by the Board, and denied, how can I appeal?

Any further appeals and comments must be made to the Board in writing. Due to the volunteer nature of our board, we are unable to handle inquiries or comments via telephone or in person.
